- Association meetings will be quarterly or as requested and facilitated by the AEC administration

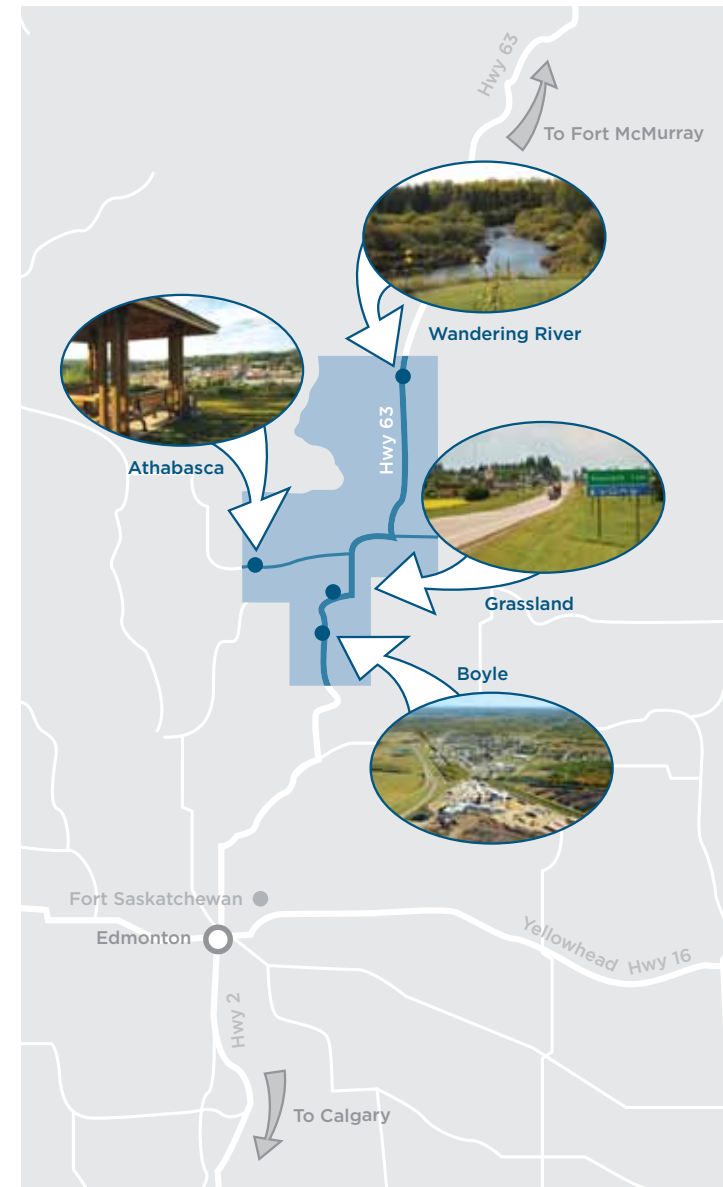
